POSITION SUMMARY:

The principal objective of this position is to work with the Rohingya community in Springvale to design and implement a project. The project will support Rohingyan women and men to connect with other communities, make friends, learn and teach skills for fun or to make money, explore men and women's roles in the community and support adjusting to life in Australia.

POSITION ACCOUNTABILITY:

- Participate in Community Engagement and Project team induction as an employee of Link HC
- Participate as an active member of the Community Engagement and Projects team
- Participate in training to build on skills relevant to undertake this role and build capacity for future employment
- Engage and consult with the community including project participants, volunteer and Project Reference Group members
- Co-design the project with the Rohingya community to improve social capital, skills for economic participation, understanding of Australian values and access to services
- Implement project activities e.g. workshops, excursions, peer support program, referrals to other programs and services, social connections with different communities
- Build the skills of volunteers as community leaders and for employment/business
- Build the knowledge of the broader community about the Rohingya community and culture
